This grant includes the right to use the Product for promoting or publicizing any of the uses.

3. I confirm that I have the right to enter into this Agreement, that I am not restricted by any commitments to third parties, and that Producer/Station has no financial commitment or obligation to me as a result of this Agreement. I hereby give all clearances, copyright and otherwise, for the use of my name likeness, image, voice, appearance and performance embodied in the Product. I expressly release and indemnify Producer/Station and/or its officers, employees, agents and designees from any and all claims known and unknown arising out of or in any way connected with the above granted uses and representations. The rights granted the Producer/Station herein are perpetual and worldwide.

4. In consideration of all of the above, I hereby acknowledge receipt of reasonable and fair consideration from Producer/Station.
